All materials manufactured, delivered and or installed on site are property of Park Business Group Limited until fully paid for. Park Business Group therefore shall have ownership and right of title for the whole of the goods until payment is made in full. Right of title will under no circumstances pass until the goods are paid for in full. This clause shall not be superseded by the main contract terms.

Please be advised that we can only accept LAD's which do not exceed 3% of the sub-contract sum or part thereof per week.

Retention to be linked with the sub-contract works and not the main contract works and limited to 3% with 1.5% being released on practical completion of our own works.

We expect payment in full for material stored on or off site if made to a programme.

Any amendments or additions to this form of sub-contract will be agreed at the pre-contract stage irrespective of any information relating to this contained within the tender package.
